September 11, 2001 is a day no one will ever forget; a day when our freedom came under attack. The Indo-American Chamber of Commerce along with many other organizations had a “Call to Arms” meeting on Tuesday the 11th to denounce terrorism against this country. The decision to mobilize the Indian population, to show our support for those affected by the terrorism, was unanimous.

In efforts to extend the support of the Chamber to the relief efforts in New York and Washington D.C., the Chamber sponsored a blood drive at the M.D. Anderson Institute, on Saturday the 15th. (Indians For Our Country the United States). The goal of I-Focus was to help with the recovery effort of the WTC and the Pentagon bombing. IACCGH has contacted most Indo-American Organizations of Greater Houston to work in unison to collectively raise funds for the victims of the terrorist attacks in New York and Washington, D.C., and presented in a symbolic check of a quarter of a million dollars to Mayor Lee Brown.

The Houston Indian Community came together and helped in every possible to aid the victim’s families in the terrorist attacks.

The IACCGH had their October meeting on the 11th of October at the Westin Galleria hotel. Mr. Paul Frison, President & CEO of the Houston Technology Center, was the featured guest speaker. Mr. Paul Frison was elected President, CEO and Director of HTC (Houston Technology Center) in 1999.

HTC is focused on assisting and growing emerging entrepreneurial businesses emanating from Houston's four key technology sectors: aerospace, energy, information technology (hardware, software and telecommunications), and life sciences. Through its educational programs and activities, HTC promotes the advancement of technology and science, as well. Mr. Frison urged everyone to get involved with HTC to make Houston a successful organization.

The evening's talk was well received by all attendees and many questions were asked of the speaker.

TRAVEL ADVISORY ON DOMESTIC TRAVEL FOR IMMIGRANT AND NON-IMMIGRANTS

Law offices of Deepa Thakur has kindly put together this advisory to help travelers in the coming year. We understand that INS is setting up checkpoints at various U.S. airports, at both domestic and international terminals. We understand that many foreign national, whether they are lawful permanent residents or "nonimmigrant workers" (e.g., those in H-1B, L-1, TN-1 status, etc.) have been asked to present their "green card" or their passport and I-94 card. We understand that INS

officers are requesting I-797 petition approval notices in addition to the above documents.

These requests are based on Section 264(e) of the Immigration and Nationality Act. This statute requires all "aliens" over the age of 18 to carry on their person "any certificate of alien registration", under penalty of a misdemeanor criminal conviction. INS regulation 264.1 (a) defines an I-94 card as a "prescribed registration form". Such a conviction is punishable by up to 30 days imprisonment, a \$100 fine or both. For the time being, it appears that such checks for identification are only being conducted at U.S. airports, for both domestic and international travel.

All nonimmigrant foreign nationals traveling within the United States or abroad should be prepared to carry their passport, their I-94 card, and their I-797 petition approval notice. Those who are lawful permanent residents should carry their alien registration cards (green cards) or other evidence of lawful permanent residence (e.g., a foreign passport with I-551 ADIT stamp). Since these documents are critical, extreme caution should be taken to protect against their theft, loss or damage.

**IACCGH Lunch with Dean
Flumerfelt**

Cullen College of Eng.

Indo-American Chamber of Commerce of Greater Houston (IACCGH) hosted a successful luncheon on November 26th with Dr Raymond Flumerfelt, Dean Cullen College of Engineering. The event was well attended by members of the IACCGH and leaders and members of several local minority Chambers of commerce. The attendees had an opportunity to network with their peers and have their minds expanded by the insightful talk given by the Guest Speaker.

Dr. Flumerfelt took over as Dean of the Cullen College of Engineering in August of 1998. Before which he was a faculty member for seventeen years. Dean Flumerfelt participated in securing a 50 million dollar grant from the State of Texas for Engineering and Science Building. In his quest to set up the Cullen College as a leading institute of engineering he has set up an Engineering Leadership Board. This is the first of many steps towards making the college a Tier I institute similar to UT and Texas A & M.

Dr. Flumerfelt enlightened the audience about the new global challenges that everyone should be prepared to face. He stressed that the "Social Contract" of yester-years was in the past and now there is a permanent downsizing by all companies. He strongly recommended two books to learn more about the Global Marketplace, "Future of Capitalism" and "Building Wealth" both by Lester Thurow. In 1990's alone two and a half million jobs were downsized, said Dr. Flumerfelt. He said another book "Straight from the Gut" by Jack Welch talks about the new trend in out sourcing and being central to global competitiveness.

The numbers of science graduates in the US have always been well below Asia and Europe. In 1996 the number of engineering and science graduates were about 63,000 versus 343,000 in Asia. But US has the most number of PhD's mainly from Europe and Asia. This is a resource US and Universities count on heavily.

Switching tracks, Dr. Flumerfelt, gave tips on how to stay in the running and improve one's marketability. He pointed out it was the smaller companies

which offer more opportunities versus large corporations He urged new graduates and old ones to maintain their mobility by constantly updating their knowledge, sharpening their expertise and thinking like entrepreneurs instead of like engineers. Keep abreast of the new trends and business opportunities and do not pigeon hole oneself by becoming too specialized in one field, he advised. Houston is the hotbed of entrepreneurship said the doctor. He recommended Universities adapt their curriculums to suit the demands of the new global marketplace. His recommendations, to universities, are that they should enhance learning abilities of the students by providing a strong knowledge base to build on. Degrees need to be wider, for example Engineers should also leave with a working knowledge of finance, marketing and law. Thereby allowing them to see the big picture similar to MBA students who only see the big picture and not the details. What the Dean would like to see is a hybrid of students who have the ability to be detail oriented and also see the big picture.

This very interesting and informative talk was followed by a question answer session that involved active audience participation. Mr. Ashok Shah, President Elect of IACCGH, gave the vote of thanks and echoed everyone's sentiments when he commended the Dean on the quality of the informative and mind expanding talk given with such ease and eloquence. Business reporter Ed Mayberry of KUHF 88.7 FM covered this event.
